PURPOSE:

The purpose of this report is to provide an update on the progress and performance of the Violence Reduction Program ("VRP") for Q1 2024 from both Programs and Partnership ("PAP") and the Community Safety Unit ("CSU").

RECOMMENDATIONS:

It is recommended that the CSAC receive this report for information and forward it to the Tenant Services Committee ("TSC") for information.

REASONS FOR RECOMMENDATIONS:

At its meeting of June 27, 2019, Toronto Community Housing's Board of Directors directed staff to operationalize the Violence Reduction Program ("VRP"). This report provides an update on activities and performance of the VRP.

BACKGROUND:

The VRP has been developed with the objective of enhancing the safety and security of tenants residing in Toronto Community Housing ("TCHC") properties. This initiative was launched in response to the disproportionate incidents of violence at TCHC properties, which are primarily rooted in poverty, addiction, mental health issues, and street involvement among the tenant population.

The VRP adopts a comprehensive approach that encompasses enhanced enforcement activities through the deployment of dedicated, on-site CSU staff, close collaboration with the Toronto Police Service ("TPS"), and the implementation of economic development programs and community and social support measures in partnership with the City of Toronto (the "City").

The VRP recognizes the need for a multifaceted response that can address the underlying social and economic issues that give rise to violence in these communities. Through the collaborative efforts of TCHC, TPS, and the City of Toronto, the VRP aims to improve living conditions and quality of life for TCHC tenants, while also fostering a safer and more secure environment for all residents.

Programs And Partnerships VRP Update:

Integrated Safety Coordination Teams ("ISCT")

Programs and Partnerships staff continue to attend monthly integrated Safety Coordination Team ("ISCT") meetings with stakeholders including Toronto Police Service, Toronto District School Board, and the City of Toronto. Recently, all six ISCT teams met for an engagement session focused on youth violence trends, seeking to identify areas for improvement within the ISCT process. Additionally, Programs and Partnerships staff are actively supporting the Toronto Office to Prevent Violence ("TOPV") in planning a gun violence prevention conference that will take place in Q3 2024.

Integrated Team Meetings ("ITM")

Programs and Partnerships staff participate in internal TCHC Integrated Team Meetings ("ITM") across all program sites. Staff continue to seek to implement a standardized process to incorporate supplement information gathered at ITMs with data from other sources, including partners at TOPV. The aim is to identify and intervene in situations to prevent violence, employing social development, prevention, intervention/interruption, and response/recovery approaches effectively.

Program Realignment

Programs and Partnerships VRP is currently undergoing a realignment of portfolios, with emphasis on preventing gun violence and de-emphasizing the factors contributing to tenant vulnerability. This realignment aims to align the work of Programs and Partnerships more closely with the operations of the TOPV. As part of this process, partnerships, initiatives, and responsibilities in communities with chronic vulnerability are transitioning to Regional teams and the Programs and Partnerships' Complex Tenancies team. Comprehensive plans are being put in place to ensure a seamless transition without resource gaps. Eagle Manor and Dunn Ave are two pilot sites affected by this transition. Please refer to Attachment 1 for Q1 2024 VRP supporting data.

Community Safety Unit VRP Update CSU Staffing Update

In February, the Community Safety Unit underwent a service-wide redeployment resulting in staff moving into permanent positions within the VRP. Currently, there are two open positions within the VRP, being filled with patrol staff as per operational requirements, and five vacancies due to secondments and leaves. This redeployment has brought about greater consistency among VRP officers. The VRP is comprised of a high percentage of junior officers, who are actively familiarizing themselves with the communities they serve.

While twelve VRP positions remain on hold, the Mobile Community Engagement and Response Team ("MCERT"), part of CSU, continues to be deployed, serving as a modified delivery model for pilot sites that require concentrated efforts from CSU, in collaboration with internal and external agencies.

CSU Update in High Needs Communities^[1]

VRP Special Constables continue to attend their weekly Integrated Team Meetings ("ITM") in Dan Harrison, Bleecker/Wellesley, Moss Park, Regent



Park, Lawrence Avenue East, and monthly ITM for 2195 Jane Street. The VRP CSU continue to collaborate with external and internal partners in the community and efforts are underway to strengthen collaboration with Toronto Police Services ("TPS") Divisional Neighborhood Officers, ensuring effective and coordinated community policing. The MCERT team remains actively engaged in both the VRP and high-risk communities as needed, enhancing flexibility in CSU responses.

<u>CSU Performance Measurement And Analysis (Q1 2024):</u> CSU Calls for Service in VRP Communities

A detailed breakdown of calls for service and actions taken in VRP Communities during Q1 2024 is provided in Attachment 1, Tables 2 and 2a, with pilot sites shown separately in Table 2b. Note, the data shown for this quarter is only up to March 25th due to Records Management System ("RMS") switch over.

Compared to Q4 2023, there was a decrease of 45 calls, particularly in Neighbour Disputes, False Fire Alarm and Parking incidents. Compared to Q1 2023, there was a decrease of 129 calls, mainly due to reductions in Neighbour Disputes, Welfare Check and Parking incidents.



Calls for service in VRP Communities¹


¹ One call may have multiple incidents reported. Figure 1: Calls For Service in VRP Communities Q1-2023 to Q1-2024

Crime in TCHC's VRP Communities (Property and Persons)

Attachment 1, Table 2c provides a detailed breakdown of crimes against persons and property in VRP communities, including seniors, family, and family pilot sites. Note, the data shown for this quarter is only up to March 25th due to RMS system switch over.

Crimes against Property

Compared to Q1 2023, there was an increase of 23 incidents (14%), driven by reported Thefts and Mischiefs. Additionally, there was an increase of 12 incidents compared to Q4 2023 primarily due to increases in reported Mischief incidents.



Crimes against Persons

Following a decrease last quarter, crime against persons increased by 11 incidents (18%), primarily driven by increases in reported Robbery, Homicide and Assault incidents. However, there were 18 incidents less than the peak observed in Q2 2023.



Crimes Against Persons in VRP Communities

We continue to work with the City of Toronto on mapping shooting incidents in TCHC Communities, data is expected to be available for the Q4 2024 VRP report.

Crime Prevention Efforts

CSU remains committed to reducing and preventing crime on TCHC properties, particularly within the VRP sites, utilizing safety audits incorporating Crime Prevention through Environmental Design ("CPTED") principles to inform recommendations aimed at fostering a safer environment. 22 safety audits were conducted in Q1 2024.

Efforts to enhance collaboration with TPS Divisional Neighborhood Officers and the active involvement of the MCERT team in both the VRP and highrisk communities are anticipated to contribute to additional crime prevention through effective and coordinated community policing.

CSU patrols serve as proactive measures to deter crime and build relationships with tenants, site staff, and stakeholders. Patrols, conducted on foot or mobile totalled 1,430 in Q1 2024, including joint efforts with Toronto Police. Patrol schedules are contingent on VRP CSU officer availability, TPS availability, and community needs.

Special Constables, Field Intelligence Officers ("FIO") and Community Safety Advisors ("CSA") participate in integrated community meetings with site staff to discuss crime trends and reporting, and to customize response strategies for individual communities. In addition, Special Constables, CSA's and FIO's attend intelligence sharing meetings along with Toronto Police and other agencies to exchange information and collaborate on crime prevention strategies.

CSAs prioritized engagement activities to improve communication and address safety issues within communities. These initiatives include community events, presentations, critical incident response, safety meetings, tenant management meetings and tenant visits. However, there was a decrease in engagement activities at the VRP sites due to resource and tracking challenges, as outlined in Attachment 1 Table 2.

VRP initiatives are aimed at fostering safer communities, by building collaborative relationships with TCHC/TSHC tenants, youth, seniors, staff, labour partners, city of Toronto, and other local organizations. For detailed information on Q1 2024 for Violence Reduction Program Initiatives for Programs and Partnership and CSU, refer to Attachments 2 and 3 respectively.

In collaboration with regional teams, TCHC's Legal Services Division plays a critical role in crime prevention and intervention by issuing eviction notices, including N6 (illegal acts), N7 (health and safety) and N5 notices for antisocial behaviours such as interfering with others, damage to property, and overcrowding. These notices underscore TCHC's commitment to maintaining a secure living environment for all tenants. Refer to Attachment 1, Table 2 for a detailed breakdown of notices for eviction.

IMPLICATIONS AND RISKS:

With twelve CSU VRP positions vacant and on hold as directed by the Board, existing front line patrol staff within CSU fulfill these duties as needed.

While serving current VRP sites and five pilot sites, maintaining coverage poses challenges as officers may be called to respond to priority calls or critical incidents throughout the City, potentially leaving any VRP locations unattended or underserved, leading to possible increases in anti-social activities.

Table 1: Q1 2024, Violence Reduction Program Initiatives led by Programs
and Partnerships

Initiatives

Attended Community Police Liaison Committee meetings in Yorkwoods Village and Edgeley Village Driftwood, where resources were shared, and updates provided on TCHC initiatives to deliver community programming and improve lighting.

In partnership with the City of Toronto and the Boys and Girls Club, supported a team of community leaders to launch Changing Lanes, a youth-led community initiative that brings workshops, counselling, and programs to Yorkwoods Village.

Brought a group of youth from Edgeley Village Shoreham on a tour of McMaster University and a workshop on education and sports.

Initiated a collective response to tenant concerns at Downsview Acres. Partners include Engagement, Active Living, Community Safety Unit and Toronto Police Service.

Partnered with Engagement to open the iHelp community space in Kipling Mount Olive, starting with a drop-in program with 23 Division Neighbourhood Community Officers. VRP and Engagement have been conducting community consultations to get tenant feedback on the operation of the space and to determine the type of programming the community wishes to have available.

Entered into partnership discussions with Jane Neighbourhood Alliance Services to bring its youth violence prevention programming to 5 Bellevue.

Initiated partnership with Engagement, Toronto Seniors Housing Corporation, Toronto Police Service and TCHC tenants to take a collective approach to preventing violence in the area of the Dan Harrison Complex and William Dennison Apartments.

Staff vacancy in the Morningside Coronation community has been filled. VRP is supporting programs in the local community space, named our space. Programming includes a restorative justice program. Staff have also begun identifying and supporting those at risk of involvement in violence. Initiatives

VRP staff developed a community development framework for the underdevelopment iHelp Centres, focusing on tenant engagement and training.

VRP continues to connect East Region tenants to employment opportunities through its partnership with Access Employment.

Partnered with Engagement to provide resources and support to vulnerable families in the East Region.

Initiated a resident-led safety network in Kingston Gallloway. Responsibility for the network will be coordinated between tenants and the East Region.

Established a safety network for the O'Connor Drive community. Next meeting is scheduled for May 2024.

Completed problem analyses to identify causes of violence in several VRP communities. Lessons from the problem analyses will be applied to planning future programs and initiatives.

Community initiatives provide CSU Staff with the opportunity to engage with tenants in a less formal manner. This interaction facilitates connections between staff and community members who may not typically interact. Such exchanges enable officers to obtain valuable information regarding community issues that tenants might not necessarily report through service calls, thereby identifying underlying problems within the community that may otherwise go unreported to our staff.
