

#### **Deputation Policy for Stakeholders**

#### PURPOSE:

This report proposes actions arising from the review of Toronto Community Housing Corporation's Deputation Policy for Stakeholders.

#### **RECOMMENDATIONS:**

It is recommended that the Governance Communications and Human Resources Committee direct staff to:

- 1. Create educational resources for tenants, including updates to the Deputation page on Toronto Community Housing Corporation's website, to provide advice to tenants and members of the public regarding the way they can make deputations;
- 2. Develop and implement an email distribution list advising interested parties of matters that are going to be considered at future Board and Committee meetings; and
- 3. Undertake a review of Toronto Community Housing Corporation's Deputation Policy for Stakeholders to simplify the language used in the Policy.

#### **REASONS FOR RECOMMENDATIONS:**

#### **Report History:**

At its January 30, 2023 meeting, the GCHRC considered <u>Report</u> <u>GCHRC:2023-03</u> regarding the 2023 GCHRC Public Work Plan, and directed management to review the Deputation Policy as part of the annual policy review process.

At its April 11, 2023 meeting, the GCHRC considered <u>Report GCHRC:2023-16</u> regarding the 2023 Policy Review Schedule, which noted that management had identified one policy requiring Board approval for review in 2023, the Deputation Policy for Stakeholders.

At its July 14, 2023 meeting, the GCHRC considered <u>Report GCHRC:2023-</u> <u>23</u>, which provided an update on the plan for the review of the Deputation Policy for Stakeholders. In its discussion of the report, the GCHRC stressed the importance of providing education related to the deputation process as part of consultations.

#### Consultations

While preparing this report, TCHC has engaged in a consultation process to gain input regarding the actions to be recommended as part of this Policy review.

#### Tenant Survey

In March of 2024, TCHC conducted a survey of tenants to understand their opinions about the deputation process. Roughly seven hundred tenants responded to the survey, which included fourteen questions. While this survey response is welcome, only seventeen (17%) percent of respondents advised that they had ever watched a Board or Committee meeting and only thirteen (13%) percent of respondents advised that they had previously made a deputation to the Board. Nevertheless, survey responses provide insight into the way tenants perceive the deputation process to respond to their needs and interests. However, not every responses with a low response rate may not be representative of those views. A breakdown of survey responses is provided in Attachment 1 to this Report.

Survey responses with a higher response rate would suggest that respondents have not previously deputed to the Board because they did not know that they could do so or did not know how to make a deputation. Seventy-three (73%) percent of survey respondents indicated that this was

the case. A lower percentage of respondents indicated that technology limited their ability to do so.

Survey respondents expressed the greatest interest in the topics that are considered at the Tenant Services Committee and the greatest desire to make deputations at that Committee. In addition, survey respondents indicated that they would be interested in receiving email notification of upcoming Board and Committee meetings.

#### Attendance at the Tenant Advisory Committee

On March 6, 2024, the members of the Governance team attended the meeting of the Tenant Advisory Committee ("TAC") to discuss the Deputation Policy. TAC members suggested that TCHC simplify the language used in Board and Committee reports so that they are more accessible. A similar recommendation was made about the Deputation Policy itself.

TAC members also made suggestions regarding the meeting process. They suggested that TCHC consider shifting the time at which Board meetings take place, as tenants may be at work or at school when the Board is meeting. They also suggested that it was important that Board meetings are scheduled consistently at one location so that tenants know where to go if they want to attend. Additionally, they suggested that TCHC consider adopting measures that would expand the ability of tenants to depute at meetings that they cannot attend, by recording their deputation in advance.

TAC members made suggestions regarding the need for tenant education. They suggested that TCHC host tenant education sessions at which they teach tenants how to participate by focusing on giving a good deputation and the requirements in the Deputation Policy. Alternatively, TAC members suggested that TCHC create a staff position to assist tenants in preparing deputations or worksheets that would provide step by step instructions on how to prepare a deputation.

TAC members suggested that members of the Board who are TCHC tenants might provide regular updates to tenants regarding matters before the Board.

#### Focus Group Discussions with Prior Deputants

In April of 2024, TCHC undertook two Focus Group discussions with prior deputants. Each Focus Group session was attended by approximately 6 to 12 former deputants. Participants were asked to respond to three questions, and in response, provided the following advice that is summarized in Attachment 2 to this report. In general, participants expressed an interest in greater, more effective communication about matters that are being

considered by the Board and its Committees and opportunities to provide education to tenants regarding the deputation process so that it is more accessible to them.

#### **Board Survey**

Between April 17, 2024, and May 3, 2024, TCHC conducted a survey of Board members to learn their views about the deputation process. Generally, directors who responded to the survey indicated that they believed that it was important to hear from deputants, that the process through which tenants can use deputations to communicate directly with the Board contributed positively to the Board meeting process and that the five (5) minute limit to deputations was appropriate.

Directors expressed differing views regarding elements of the deputation process that did not work well. Directors generally expressed an interest in expanding the number and diversity of tenants who make deputations to the Board. Directors expressed different views as to the importance of ensuring that tenants hold to the Agenda topic to which they are deputing. Some directors expressed concerns regarding the amount of meeting time that is required for deputations when they are unrelated to topics on the Agenda, while others expressed the opinion that the Board should apply leniency to this requirement.

One Director suggested that the Board might consider receiving prerecorded video deputations and another suggested that TCHC might work with tenant groups to promote engagement with the Board. A Board member recommended that the Board should be clear with deputants about the expectation that they should be on topic, and another expressed the view that only the Board or Committee Chair should determine whether deputants have done so.

#### NEXT STEPS

No major revisions to the Deputation Policy are proposed because of this Policy review. However, based upon the feedback that TCHC has received through its consultation process, there are several actions that we can take to improve upon the way we provide tenants the opportunity to depute to the Board and its Committees and to be aware of the matters that are being discussed at the Board. These matters include:

• The addition of educational resources for tenants, including updates to the TCHC Deputation page on Toronto Community Housing

Corporation's website, incorporating advice to TCHC tenants and members of the public regarding the way they can make deputations;

- The introduction of communication tools such as an email distribution list advising interested parties of matters that are going to be considered at future Board and Committee meetings; and
- Reviewing the Deputation Policy to simplify the language used in the Policy, to make it more accessible.

#### IMPLICATIONS AND RISKS:

Pursuant to the City of Toronto's Shareholder Direction, the Board is required to conduct its business through meetings that are open to the public, subject to certain identified exemptions that authorize the Board to consider certain matters in a closed meeting. Through the Board's existing Meeting Procedures, members of the public are provided with the opportunity to make deputations to the Board, as part of its public meeting process.

In this regard, the Board recognizes that deputations to the Board are an important aspect of the Board meeting process through which deputants provide the Board with information and clarify issues, not available in writing or not brought before the Board as part of a staff report. The information provided to the Board in this way can and does facilitate better decision making by the Board.

At the same time, Directors are required, in the exercising of their powers and discharging their duties, to exercise the care, diligence and skill that a reasonably prudent person would exercise in comparable circumstances. Complying with this standard of care requires that meetings of the Board and its Committees are conducted efficiently and effectively and that directors are afforded the time that they require to address the various matters on the Board agenda.
