#### **PURPOSE:**

The purpose of this report is to provide the TSC with an update on the implementation of the Tenant Engagement System Refresh.

#### **Reason for Recommendation:**

The report outlines the work of the Tenant Engagement unit and local teams in support of TCHC's commitment to promoting tenant involvement, fostering communication, and enhancing the overall tenant engagement experience.

# **Tenant Advisory Committee**

The Tenant Advisory Committee advises Toronto Community Housing on the implementation of the Tenant Engagement System and corporate initiatives that advance tenant priorities.

# **Tenant Advisory Committee Meetings**

The June 12, 2024, meeting of the Tenant Advisory Committee ("TAC") included:

 An update on the implementation plan of the Tenant Engagement Review.

- Breakout sessions to discuss the structure of the Tenant Engagement System.
- TCHC staff were asked to develop three tenant engagement models informed by the input provided by the TAC members for review at the next TAC meeting.

The July 10, 2024, meeting of the Tenant Advisory Committee included:

- A presentation of three alternative Tenant Engagement System models.
- TAC members provided their input and preferences on the three alternative engagement models.

## **Tenant Community Action Tables**

The Tenant Community Action Table brings together a diverse group of stakeholders who collaborate closely with tenants, staff, and partners. Its primary objective is to address the tenant-identified priorities within each community, forming the Tenant Community Action Table. To achieve this, the following key objectives have been established:

- 1. Share information and resources.
- 2. Build a Community of Practice; and
- 3. Capacity building of community representatives.

# **Tenant Community Action Table – Q2 2024:**

In June 2024, KPMG facilitated three regional Tenant Community Action Table (TCAT) meetings in partnership with Engage Delaney and TCHC. In small groups, Community Representatives, guided by a facilitator, used the bridge exercise to inform the consultancy group on their lived experiences as TCHC tenants. They shared input on their ideal future state of a TCHC tenancy, as well as the current state experience. Follow-up reporting on the TCAT will be shared with community representatives, in the coming weeks.

## **Capacity Building**

On August 7<sup>th</sup>, 2024, the Mayors Office's Community Engagement team, in partnership with TCHC, hosted a personal narrative training based on the Ganz model of social change to help strengthen staff and tenants' capacity to lead. The event was facilitated by Mayor Olivia Chow and saw participation from TCHC CEO, Sean Baird, 15 tenants selected through a lottery process, and 25 frontline and management staff.

## **Next Steps**

TCHC is committed to promoting tenant involvement, fostering communication, and enhancing the overall tenant engagement experience within TCHC. Over the coming months, TCHC will:

- Submit the Tenant Funds for Common Area Projects (formerly known as participatory budgeting program) program redesign and the Tenant Engagement System Review Implementation Plan to the Tenant Services Committee.
- Continue enhancing tenant capacity building through training and workshops.
- Coordinate monthly TAC Meetings, including consultation on key programs of the Tenant Engagement System.
- Host quarterly TCATs

# Implications and Risks

The City's Shareholder Direction requires TCHC to maintain a democratic system of active tenant participation and involvement that will provide the following:

 Opportunities for tenant engagement regarding their housing and the complete TCHC housing portfolio.

- Opportunities for tenants to provide input on TCHC corporate decisions, including capital plans, operating budget, service levels, service delivery and Tenant facing policies; and
- Opportunities for tenant input on setting local spending priorities; and
- Information about opportunities for engagement in other City and community initiatives.

In addition, TCHC's approach to tenant engagement will respect the terms of the Shareholder Direction and the financial targets and performance benchmarks established for TCHC by the Service Manager.
